- Copy of current driving record and conviction history including Blood Alcohol level (If applicable)
- An attorney may have this information already. If so it will be necessary for it to be produced at the first meeting.
- A current 10-panel drug screen. This can be ordered on line from this office after the evaluation process
- It will be important to provide information specific to current living and employment situation, lifestyle changes, prescription drugs that have been or are currently being taken and any other contributing factors relative to sobriety,
- Notarized testimonial letters



The appeal

<u>Details are Vital!</u> "Clear and Convincing Evidence"

For an appeal to be successful the Hearing Officer must be left with a definite conviction that a substance abuse problem is under control and that recovery can be achieved with a minimal risk of repeat behavior.

Drivers license restoration is a complicated process, usually requiring the assistance of a knowledgeable attorney who understands exactly what the Hearing Officer will be looking for and will assist in navigating the necessary steps.
